## Instructions to Dedicate Land for Agricultural Use

1. If a petitioner leases or owns multiple parcels for agricultural use, the petitioner must submit a petition for each parcel. Only one parcel is permitted on a petition. If there are multiple petitioners on a single parcel, each petitioner must file a separate petition. Multiple petitioners on a single petition will not be permitted.
2. Petitions must be filed by September 1<sup>st</sup> of any calendar year. The notice of assessment shall serve as notice of approval or disapproval of the petition for dedication. If approved, the assessment shall be effective on July 1<sup>st</sup> of the following tax year. The owner or party responsible for paying the real property tax may appeal any rejection of the report, cancellation of the dedication, or imposition of a rollback tax and penalty in the same manner as an appeal from an assessment.
3. An owner of the land may petition for dedication, or with the written authorization of the owner, a lessee, permittee or licensee may petition for dedication of the owner's land. If the ownership is in a trust, please submit the necessary documents, in short-form, stating the trustee of the trust. All fee simple owner(s) of parcel must be listed with signature(s).
4. A copy of a valid State of Hawaii general excise tax license must be submitted with the petition to dedicate by the party conducting the agricultural use activities.
5. The approval of the petition to dedicate shall constitute a forfeiture on the part of the owner of any right to change the use of the land to a use other than agricultural for a minimum period of 5 or 10 years, as the case may be, except in the case of land dedicated for a specific agricultural use where the owner files a land use change cancellation.
6. For each year following the approval of the dedication, an annual report (Form BFS-RP-P-41A) meeting the requirements of ROH Section 8-7.3 (j), shall be submitted no later than September 1<sup>st</sup>.
7. For the agricultural plan required under ROH 8-7.3 (e), submit a tax map identifying the area(s) in specific agricultural use(s) and area(s) in non-agricultural use, including the homesite, if any. Total area in agricultural use and non-agricultural use must equal to the legal area of the parcel.
